ORDER ON JOINT MOTION AND
STIPULATION OF PLAINTIFF AND INTERVENORS

THIS CAUSE came on to be heard upon the Joint Motion and Stipulation of plaintiff, OXFORD FIRST CORP., a Pennsylvania corporation, and intervenors to effectuate the transfer of the stock of Indian Lake Maintenance, Inc. to a trustee, Indian Lake Civic Association, Inc., a Florida non-profit corporation, in accordance with this Court's Order of July 20, 1984, and upon reviewing the record in this case, the Joint Motion and Stipulation and being otherwise fully advised in the premises, it is

ORDERED AND ADJUDGED that:

1. This Court has retained jurisdiction over the parties and the subject matter by virtue of its July 20, 1984 Order.
2. That Indian Lake Civic Association, Inc., a Florida non-profit corporation, whose address is P. O. Box 885, Indian Lake Estates, Fl 33855, is hereby authorized to purchase at private sale the stock of Indian Lake Maintenance, Inc., which is presently in the physical possession of counsel for the intervenors, Marie Alice Crano, Esq., P. O. Box 186, Lake Wales, FL 33859-0186.
3. That plaintiff or its agents or representatives are authorized to exercise its rights under security interest in said stock of Indian Lake Maintenance, Inc. by any legal remedies available to plaintiff, including the private sale to Indian Lake Civic Association, Inc., a Florida non-profit corporation.
4. That Indian Lake Civic Association, Inc., a Florida non-profit corporation, as successful purchaser at a private sale of



the stock of Indian Lake Maintenance, Inc., is hereby appointed trustee of that stock for the benefit of those parties established by the Final Decree of July 30, 1964, and the subsequent Order of February 16, 1966, in Special Investments, Inc. v. Indian Lake Estates, Inc., Case NO. 54238-71-532, Polk County Circuit Court, Bartow, FL.

5. The Circuit Court of Polk County shall retain jurisdiction in accordance with the Final Decree and subsequent Order in Special Investments, Inc. v. Indian Lake Estates, Inc., Case NO. 54238-71-532, as regards the ownership of Indian Lake Maintenance, Inc. by Indian Lake Civic Association, Inc., a Florida non-profit corporation, as trustee of said stock of Indian Lake Maintenance, Inc.


6. That Indian Lake Civic Association, Inc., a Florida non-profit corporation, as trustee of the stock of Indian Lake Maintenance, Inc., shall comply with all applicable provisions of the Final Decree of July 30, 1964, and the subsequent Order of February 16, 1966, in Special Investments, Inc. v. Indian Lake Estates, Inc., Case NO. 54238-71-532.
